

COVID-19 vaccination in EU Member States-1

- European Vaccination Days 27-29 December 2020: kickoff of vaccination in Member States
- Focus on priority groups, e.g. older persons and health professionals
- Mid-February 2021: Vaccination continues, but Member States need to speed up.

COVID-19 vaccination in EU Member States - 3

• Overall targets:

- By March 2021: Member States to have vaccinated ≥ 80 % of health and social care assistants and people over 80 years old
- By summer 2021, Member States to have vaccinated \geq 70 % of adult population

Ambitious but reachable

EU Strategy for COVID-19 vaccines - 1

- Commission communication of 17 June 2020
- Secure access to safe and efficient COVID-19 vaccines for EU Member States as soon as they become available
- On the basis of Advance Purchase Agreements: The Commission supports vaccine manufacturers to face upfront costs and has, in return, the right to purchase vaccines once available.
- Financial instrument: The Emergency Support Instrument (ESI)

EU Strategy for COVID-19 vaccines - 2

- <u>AstraZeneca</u>: 400 million doses
- Sanofi-GSK: 300 million doses
- Johnson & Johnson: 400 million doses
- BioNTech-Pfizer: 600 million doses AUTHORIZED
- <u>CureVac</u>: 405 million doses
- <u>Moderna</u>: 160 million doses



AUTHORIZED

- Exploratory talks concluded with <u>Novavax</u> and <u>Valneva</u>
- In total: up to 2.3 billion vaccine doses secured



The key role of health professionalsHealth professionals are:

- administrators of vaccines
- trusted sources of information
- role models.
- Health professionals can support COVID-19 vaccination in Member States.



Safety and efficacy of COVID-19 vaccines

- All vaccines go through a strict assessment and authorisation procedure.
- Scientific assessment by the European Medicines Agency
- Marketing authorisation by the European Commission
- COVID-19 vaccines: conditional marketing authorisation



High efficacy in robust clinical trials

- Efficacy ranging from 60 % to 95 %
- Size of the clinical trials: from around 10 000 to 40 000 patients
- Calculated on the number of people developing COVID-19 symptoms after injection of the vaccines or dummy injection
- Companies will continue to monitor patients and provide results of the trials (conditional marketing authorisation)



High safety in robust clinical trials

• Assessed on the basis of robust clinical trials data

• Patients continue to be monitored post authorisation

• Additional data collection for safety monitoring foreseen

- Dedicated space on the EU Health Policy Platform
- Manifesto to encourage health professionals to get vaccinated against COVID-19
